Energy Grants

The WNC Energy Cost-share Assistance Program (EnergyCAP) is now accepting grant applications from WNC farmers looking to fund energy projects for their operations through its Small Farm Energy Grants Program, a new program funded exclusively by the NC Tobacco Trust Fund Commission. The program offers 25% cost-share grants for energy technologies that reduce farmer operating costs, lower environmental impacts, and increase the farm's bottom line, such as LED lighting, greenhouse insulation and heating upgrades, and renewable energy generation from

solar panels and other sources. The grant can be combined with USDA's REAP grant (also a 25% cost-share) for possible combined 50% cost-share.

"We get a lot of interest in grant funding for these projects from WNC farmers, but a lot of the time they need the process to offer more funding at the other end, or to be easier," said Alex Arnold, the project coordinator for EnergyCAP. "We're hoping this grant can be that funding bridge for farmers trying to cut down on their energy costs and energy usage."

EnergyCap is a nonprofit program that provides free on-site or over-the-phone consultations on farm energy needs, as well as application assistance for farm energy grants. Since 2009, the program has facilitated over \$480,000 in cost-share funding for the installation of over 70 energy projects for WNC farms, including 37 photovoltaic systems, 7 wind turbines, 7 solar hot water heating systems, a micro-hydro system, a biomass project, 3 passive solar greenhouses, and 2 geothermal greenhouse heating systems.

"We have tried to make this application much more straightforward and easy to complete than what you might experience with the federal grant programs. But we can help farmers with the federal grant applications, too," said Arnold.

To be eligible for the program, applicants must be persons engaged in agricultural production; current or former tobacco farmers will be given priority.

2017 Tax Tips



Today's Tax Tip

Changes are occurring to due dates for 1099 forms this year. The recipient due date and the IRS due date is now January 31,

2017. If you miss the deadline the penalty for each form 1099 not timely filed is \$250.

Who do you need to send a 1099 to anyway?

Vendors you payed over \$600 during the calendar year for the following:

- ◆ Services for custom harvesting, spraying or other field work
- ◆ Services for professional fees
- ◆ Veterinary services
- ◆ All rents paid for cash rents, machinery rentals, etc.
- ◆ Interest paid out to non-financial institutions

Pesticide Exam

On Wednesday and Thursday, May 10 & 11, 2017 the Avery and Mitchell County Centers of North Carolina Cooperative Extension Service will

be offering a private and commercial applicator pesticide licensing school. This school is for farmers needing to purchase restricted use pesticides to apply on their own or rented land. The school will also be for those individuals desiring to get a license to apply pesticides commercially to landscapes, agriculture plants and animals, right-of-ways and golf courses. Other licensing areas include regulatory, demonstration and research, forestry, aquatic and dealer. The two (2) day school will run from 9:00 a.m. til 5:00 p.m. on Wednesday and from 9:00 a.m. til 12:00 noon on Thursday. At 1:00 p.m. on Thursday a NCDA&CS Pesticide Inspector will be on hand to administer the test. The pesticide school and test will be held at the Avery Campus of Mayland Community College in Newland.

Voluntary Agriculture Districts

Voluntary agricultural districts (VAD) recognize the importance of agriculture to the economic and social well-being of North Carolina by encouraging the voluntary preservation and protection of farmland from non-farm development.

Districts are made up of the contiguous acres of qualifying farmland or the number of qualifying farms deemed appropriate by the county agricultural advisory board.

Presently the Mitchell County Voluntary Agricultural District program has twenty-nine (29) landowners enrolled representing over 4,000 acres of farmland in the program.

What Qualifies a farm to Be in an Agriculture District?

—Farmland, forestland, and horticultural lands must meet the following criteria

- The land must be part of the present-use-value taxation program or be determined to be eligible for present-use-value; and
- The land must be managed in accordance with USDA Natural Resources Conservation Service guidelines with respect to highly erodible land.

What are the requirements for the Program?

- The land must be subject to a conservation agreement between the landowner and the county or local municipality that prohibits non-farm use or development for a period of at least 10 years, except for the creation of not more than three lots that meet applicable county zoning and subdivision regulations.
- This agreement may be revoked by the landowner at any time, usually with only a short period of advanced notice, such as a 30-day notice. Ending the agreement will result in the property no longer qualifying for the VAD program and its benefits.

What are the Benefits of Participating in the Program?

- Increased protection from nuisance lawsuits if notice is provided through computerized


county land records system or the county register of deeds office.

- Public hearing for proposed condemnation of enrolled land.
- Water and sewer assessments may be suspended or waived if the land is in VAD but not connected to the utility in question.
- Possible signage to publicize the land's enrollment in the program.
- Greater public awareness of the local community and increased pride in its way of life.
- An agriculture advisory board will be formed to approve applications and to also be a voice for agriculture in county government.
- District members may be eligible for farmland preservation funds as local, state, or federal funds become available.
