• For State Finals: Use questions from the District Judging and answer those questions in your re-recorded presentation for State judging. Be sure to say in recording that the judges had these questions from the district and you are answering them if that is Applicable.

• Winners will be announced with some type of "virtual" ceremony with winner

• 4-H'ers it is your time to be as creative as you like in how you manage this new way of doing things this year.
